

Workers' Compensation, Unemployment Compensation, and Social Security/Medicare

Federal and state laws determine the eligibility requirements and the type of coverage for these benefits. Students may be exempt from some benefits.

Workers' Compensation

OSU provides Workers' Compensation (WC) coverage for all employees for work-related injuries or illnesses. The coverage provides reasonable and necessary medical treatment and some income replacement. In addition, an injured employee may be entitled to prosthetic devices, physical rehabilitation, vocational rehabilitation, or permanent disability compensation. If the work-related injury or illness causes death, the employee's dependents may be entitled to additional benefits.

Employees shall notify supervisors immediately when a work-related injury or illness occurs so that medical attention may be provided if needed. Medical treatment will be provided at designated health care providers when available. University Health Services will provide non-emergency care within the Stillwater area during normal business hours. Supervisors report work-related injuries and illnesses through the OSU WC process described at http://hr.okstate.edw/benefits/workcomp. For injuries or illnesses occurring on or after February 1, 2014, the official waiting period is three full days of absence following the date of injury or illness, as required by the treating physician. After the waiting period lapses, Broadspire, OSU's third-party administrator, will pay for qualified absences as required by Oklahoma statute. If the employee does not wish to use their leave for the official waiting period (three days) or to supplement payment from Broadspire after the waiting period, the employee must provide a written request to their supervisor.

Employees on an extended WC leave (a full month or longer without pay) should contact the Absence Management Specialist at (405) 744-7401 or absence@okstate.edu. You may qualify for Family Medical Leave (FMLA), and that benefit would run concurrently with your WC leave. OSU-paid health coverage will continue during WC leave. Life coverage will continue for no longer than one year unless an LFG life waiver is approved due to disability. Employee-paid benefits will be billed through the Bursar's office if there is insufficient pay to take the deductions.

The Oklahoma Workers' Compensation Commission's Counselor Program, at 855.291.3612, offers employees free, private counseling concerning work-related injuries or illnesses. Unemployment Compensation Insurance

The provisions of the Oklahoma Employment Security Act apply to most OSU employees. OSU pays the full cost of these benefits. The <u>Oklahoma Employment Security Commission</u> determines a terminated employee's eligibility for unemployment benefits based on the circumstances of the termination.

Social Security/Medicare

Both you and OSU contribute to Social Security and Medicare. Benefits provided by Social Security include old age, survivors, and disability insurance and are explained in detail at www.ssa.gov. Medicare benefits include Part A (hospitalization), Part B (medical insurance), and Part D (prescription coverage).
