Thinking About Retirement?

Wonder what your retirement income might be? Check out the Social Security, TIAA-CREF and OTRS websites for estimates of retirement income.

- TIAA-CREF Website www.tiaa-cref.org log in and select Generate a Retirement Illustration under Manage My Portfolio.
- OTRS Website www.ok.gov/TRS select Retirement Benefits and use the calculator to estimate your monthly retirement benefit for selected dates based on service and salary information you enter. You may also request a calculation from OTRS.
- Social Security Administration www.ssa.gov/ **estimator** - find out how to plan your retirement, calculate benefits and apply for retirement benefits. Calculations are based on your actual Social Security earnings record.

Celebrate Wellness at Staff Appreciation Day, April 2

Take advantage of wellness opportunities at the annual Staff Appreciation Day, Thursday, April 2.

Screening: Stop by the OSU Telemedicine bus, located outside Willard, on Thursday, April 2, from 9:00am - 4:00pm. OSU Seretean Wellness Center staff will be available to administer blood tests (fasting or non-fasting)*, blood pressure measurements, and height/ weight measurements. Employees who choose to fast for the blood work can also have a lipid panel done free of charge.

Counseling: Also available will be individualized and immediate counseling from a Registered Nurse, Exercise Specialist, and Physician Assistant (PA available from 1:00 pm - 3:00 pm only). There will be no out-ofpocket expense to employees, but you must bring your BlueCross BlueShield insurance card.

Health Risk Assessment: Take your results to the computer lab in Willard and complete the online Health Risk Assessment, www.bcbsok.com/osu. All participants who complete the HRA (both blood work and online questionnaire) will be entered into a drawing for a chance to win either an iPod shuffle, or an iPod Nano (complete with docking station and a \$25 gift card to iTunes), compliments of BlueCross BlueShield of Oklahoma. Join us as we strive to make OSU America's HEALTHIEST Campus.

Cowboys on the Move: Staff will also be available to assist in setting up an account with Cowboys on the Move, a web-based program designed to challenge all OSU employees to become more physically active.

*If opting for a fasting blood test, do not eat or drink anything after midnight (except water).

Making Work Pay Provision of the American Recovery and Reinvestment Act

For tax years 2009 and 2010, the Making Work Pay provision of the American Recovery and Reinvestment Act (ARRA) will provide a refundable tax credit of up to \$400 for working individuals and \$800 for married taxpayers filing joint returns. Because the credit is refundable (people can get it even if they owe no tax), most low-income workers will qualify for the full credit.

Taxpayers will not receive a separate check from the IRS like they did with last year's economic stimulus payment. The benefit will be spread out over the paychecks they receive beginning this spring and continue until the end of the year. Eligible workers do not need to fill out new W-4 withholding forms to receive the Making Work Pay credit. New federal withholding tables are incorporated in the payroll calculation and most workers will see an increase in their take-home pay.

New Format to BlueCross BlueShield Member ID Cards Coming Soon

BlueCross BlueShield of Oklahoma is in the process of phasing in new ID cards. The new ID cards have a magnetic stripe on the back and provide information about the member's health plan.

When a member visits a doctor's office or hospital, the office staff may slide the new card through a card-reading device to get basic information about the member's health plan. Any member information contained in the magnetic stripe can be read only by health care providers with certain card readers, software and connectivity. However, not all health care providers have card-reading devices at this time. The new technology should make the eligibility and benefits verification process more efficient.

The new card is not a credit or debit card. There is no financial or personal medical information stored on the card

The new card looks slightly different from previous cards. While BlueCross BlueShield is in the process of phasing in the new card, some members may have the new card while other members may still have the older version of the ID card. Both versions of the ID card are valid until January 1, 2011.

Updated List of 403(b) Tax-Deferred Annuity Providers for 2009

403(b) plans, tax-deferred annuities, offer OSU employees an opportunity to set aside additional retirement savings on a voluntary basis. Contributions are deducted from your paycheck on a pre-tax basis (federal and state but not FICA). All employees paid through the OSU payroll system are eligible to participate.
