New Overtime Rule

- On September 24, 2019, the U.S. DOL announced the final ruling under the FLSA for overtime exemption Standard Salary level of \$684 per week (\$35,568 per year)
 - Effective January 1, 2020
 - HR will be working with Colleges/ Divisions to identify potential changes in early 2020
